In Maricopa County, call (602) 257-4434 between the hours of 8:30 am and 5 pm Monday – Friday. Non-refundable \$40 fee (no fee for workers' comp or personal injury).

In Pima County, call (520) 623-4625 between 9 am and 4:30 pm, Monday – Friday. Non-refundable \$35 fee.

The NEA Attorney Referral Program

NEA's Attorney Referral Program provides members with legal advice on personal matters in five core areas.

Who Can Participate

NEA's Attorney Referral Program is open to any member including active, life, support, student, or retired member, and the member's spouse and dependent children.

What The Program Provides

Your national and state Associations have identified attorneys throughout the state who have agreed to handle certain personal matters at a substantially reduced rate.

During any membership year, eligible members are entitled to two free 30-minute consultations on "core" areas with any of the attorneys listed. The two free consultations may not be in the same "core" area.

In addition to these free consultations, members may have legal work performed in the five "core" areas at a 30% reduction of that attorney's normal hourly fee.

Wills may be prepared for a flat fee. In that case, members receive a 30% reduction of the attorney's normal flat fee.

Not Covered: Employment, criminal and bankruptcy matters are not covered. See listings for the types of services offered by each attorney. See your AEA Organizational Consultant for assistance with school employment problems.

The 'Core' Areas

NEA has identified five "core" areas of personal legal service for coverage under the NEA Attorney Referral Program.

1 – Wills and Estates

At a 30 percent discount rate, you can have a participating attorney prepare your will, assist with estate planning, provide legal assistance if you are named the executor or administrator of an estate, or offer legal counsel in guardianship proceedings.

2 – Real Estate

Participating attorneys will provide assistance with the purchase or sale of residential property, disputes with landlords, property line controversies, and problems with zoning laws or land use regulations.

3 – Family Law

Participating attorneys provide representation in proceedings for annulment, divorce, separation, alimony, custody, child support, guardianship, adoption, paternity, and name changes.

4 – Consumer Protection

Participating attorneys will provide assistance at the discounted fee for disputes with creditors or finance agencies and proceedings with retailers concerning defective merchandise.

5 – Traffic Violations

You can receive legal representation to handle charges of driving under the influence, reckless driving, or other traffic offenses.

How You Can Take Advantage of this Program

The names, addresses, and telephone numbers of the NEA-approved attorneys participating in the program in your state are listed in this brochure.

You may contact the attorney directly and identify yourself as an NEA/AEA member participating in the Attorney Referral Program. You can also contact AEA headquarters or your local regional office for more information.
